

PRIVACY POLICY

Dear visitor,

we highly respect your privacy and this document describes how your personal information is collected, used, disclosed, shared and stored by JP Online Matchmaking Club. The Privacy Policy applies to any interaction with www.lanske.club.

Our company may at any time change, modify, or otherwise update this Privacy Policy without prior notification.

PERSONAL DATA COLLECTED

Personal information that you provide directly through contacting us or filling out the request forms on the website, will be apparent from the context in which you provide the information. Such data as your full name, email and postal address, phone number, date of birth, preferable language and further details are collected as a part of business relationship. We will use this information to contact you and provide our consultation according to your request. However, these data are optional in our request form and you are the only person to decide whether to share specific personal data with us.

When you visit the Site, the technical data about your device, including information about your web browser, IP address, time zone, and some of the cookies that are installed on your device are collected.

When you place an a request through the Site, we will maintain your Request Information for our records unless and until you ask us to delete this information.

We collect Device Information using the following technologies:

- “Cookies” are data files that are placed on your device and often include an anonymous unique identifier. For more information about cookies, and how to disable cookies, visit <http://www.allaboutcookies.org>.

Cookies are the small pieces of code which are stored on the device you use to visit our website. Cookies may be set by the website you are visiting (“first party cookies”) or by the third parties, such as cookies from a browser you are using, or may be set up by any analytical service that we use on our website. JP Online Matchmaking Club (by Lanske) uses cookies to provide you with the full content of the website in a proper visual form with all functions. Cookies are essential for the basic functioning of the website. We also use cookies which may identify users’ devices and help us to understand the users’ online activity on the website. Additionally, you can set your browser to inform you of the potential downloading of cookies. You can use your browser settings to block some cookies according to your wishes. Be aware, that blocking of some cookies may prevent you from working with all functions of the website properly.

We are processing your personal data according to Art. 6 (1) (f) GDPR for the legitimate purposes noted above.

- “Log files” track actions occurring on the website, and collect data including your IP address, browser type, Internet service provider, referring/exit pages, and date/time stamps.

- “Web beacons,” “tags,” and “pixels” are electronic files used to record information about how you browse the Site.

This website uses web analytics tools which apply such technologies as cookies, website tags (also known as the Google Analytics Tracking Code) and other tracking technologies to track visitors of the website and provide the analysis related to the users’ visiting of our website. JP Online Matchmaking Club collects the generated information related to the location, time of the visits, amount of web-pages visited on the website. We use this information to improve the level of our matchmaking service.

You may preclude the use of these tracking technologies by selecting the appropriate settings in your browser. Be aware that in this case, it may occur that you may not be able to use all functions of this website.

USE OF YOUR PERSONAL DATA

We use the collected Personal Information generally to fulfill any orders placed through the Site (including processing your payment information, arranging for shipping, and providing you with invoices and/or order confirmations).

Additionally, we use these data for:

Communication with you;

Overview of activity history;

Screening of orders for potential risk or fraud;

Storage of you personal preferences for the sake of advertising;

Other marketing initiatives;

Developments and improvements of the service;

Statistics, monitoring and reports of usage.

We use the Device Information that we collect to help us screen for potential risk and fraud (in particular, your IP address), and more generally, to improve and optimize our Site (for example, by generating analytics about how our customers browse and interact with the Site, and to assess the success of our marketing and advertising campaigns).

SHARING YOUR PERSONAL INFORMATION

In order to provide you with the best possible service, your personal data may be disclosed to the third parties which help us to process the information. Internal and external service providers, IT hosting and partners who may receive the data, use them only on behalf of JP Online Matchmaking Club and in accordance with the instructions of our company. Any kind of information is disclosed in accordance with the data protection laws.

The above-mentioned service providers are to process your personal data only according to our strict instructions and if they diligently fulfill the conditions related to adequate technical and organizational measures for reliable data protection.

Your personal information may be also disclosed in specific situations if such a decision is authorized by law. The disclosure in such cases is necessary to prevent from a threat to a life and health, ensure public and individual safety and can be further permitted by the relevant data protection laws.

The collected personal data will apart from the above mentioned situations not be used, sold, shared or otherwise distributed to any third parties without your consent, except where JP Online Matchmaking Club is required to do so because of an applicable law, court order or governmental regulation, or if such disclosure is otherwise necessary in support of any criminal or other legal investigation or proceeding here or abroad.
